This bill would declare that the diversion of water to underground storage constitutes a beneficial use of water if the water so stored is thereafter applied to the beneficial purposes for which the appropriation for storage was made, or if the water is so stored consistent with a sustainable groundwater management plan, statutory authority to conduct groundwater recharge, or a judicial decree and is for specified purposes. Amendments made to this bill require those seeking to store water underground to apply to the State Board for a permit to appropriate water or petition the board for a change. AB 935 (Salas D) Water projects. This bill would require, upon appropriation of bond funds by the Legislature, DWR to provide up to \$75 M for the Reverse Flow Pump-back Facilities on the Friant-Kern Canal Restoration Project, and the San Joaquin River Recapture Project.	Watch	
AB 937 (Salas D) Groundwater planning: technical assistance: disadvantaged communities. Would require the DWR to provide technical assistance to disadvantaged communities so that they may participate in groundwater planning, including, but not limited to, plans for regional groundwater banking, with any county or other local agency. AB 1139 (Campos D) Personal income taxes: credit: turf removal. This bill would, for taxable years beginning on and after January 1, 2015, allow a credit to a taxpayer participating in a locally approved lawn replacement program, in an amount equal to \$2 per square foot of conventional lawn removed from the taxpayer's property, up to \$50,000 per taxable year. AB 1201 (Salas D) Fish and wildlife: Sacramento-San Joaquin Delta: predation by nonnative species. Would require the Department of Fish and Wildlife, by June 30, 2016, to develop a science-based plan that addresses predation by nonnative species upon species of fish listed pursuant to the California Endangered Species Act that reside all or a portion of their lives in the Sacramento-San Joaquin Delta and that considers predation reduction for all Chinook salmon and other native species not listed pursuant to the act. AB 1242 (Gray D) Water quality and storage. Would require DWR to increase statewide water storage capacity by 25% by January 1, 2025, and 50% by January 1, 2050. The bill would require the department, on or before January 1, 2017, to identify the current statewide water storage capacity and prepare a strategy and implementation plan to achieve those expansions in statewide water storage capacity, and would require the department to update the strategy and implementation plan on January 1, 2018, and every 2 years thereafter, until January 1, 2050. AB 1362 (Gordon D) Mosquito abatement and vector control districts: board of trustees: appointment of members. This bill was originally set up to redefine "stormwater" as part of constitutional amendment to Proposition 218 so that public agencies could set rates in the same manner as water and sewer rates. It has now been amended into a bill that deals with the appointment of mosquito abatement districts trustees. AB 1376 (Perea D) State Water Resources Control Board: appropriation: drought-related drinking water projects. Would appropriate \$15,000,000 from the General Fund to the State Board, for expenditure until June 30, 2016, for grants of up to \$500,000 per project for public water systems to address drought-related drinking water emergencies or threatened emergencies in the state. The bill would require the state board to make every effort to use other funds available to address drinking water emergencies, including federal funds made available for the drought, prior to using the funds appropriated pursuant to these provisions. SB 7 (Wolk D) Housing: water meters: multiunit structures. Would express the intent of the Legislature to encourage the conservation of water in multifamily residential rental buildings through means either within the landlord's or the tenant's control including the submetering of dwelling units. SB 20 (Pavley D) California Water Resiliency Investment Act. This bill sets the stage for a Public Goods Charge. The bill itself would create the California Water Resiliency Investment Fund in the State Treasury and provide that moneys in the fund are available, upon appropriation by the Legislature, for the purpose of providing a more dependable water supply for California. This bill would create various accounts within the fund for prescribed purposes.	Watch
