MEETING SUMMARY

- Presentation topics included: Regional Drought Contingency Plan/Regional Water Reliability Plan background and process review, overview of vulnerabilities and mitigation actions/opportunities, in-depth group discussion on vulnerabilities and mitigation actions/opportunities by vulnerability category, and next steps.
- Agenda, hard copy of the presentation slides, 11x17 Vulnerabilities by Agency, and Identified Subregional Vulnerabilities and Mitigation Actions/Opportunities were distributed as materials (also attached).
- See updated Vulnerabilities and Mitigation Action/Opportunities (attached) for summary of mitigation actions discussion.
- Questions, parking lot items, other feedback and discussion items:
 - The agencies agreed that the vulnerability brought up by City of Folsom 'Low flow from Folsom Lake results in limited supply to the Folsom South Canal to Folsom WTP' is a vulnerability shared by the entire Eastern subregion.
 - The agencies discussed how a regional groundwater bank would allow for storage of CVP water and encourage conjunctive use. This would address the 'use it or lose it' water laws.
 - The agencies discussed the current limitations on their ability to share supplies. These issues include fluoridation, water rights, Reclamation approval for water transfers, Place of Use contracts, and State Board curtailments.
 - The agencies discussed the potential for expanding emergency interties and increasing intertie connections for emergency and retail water use. Folsom could expand interties connections with San Juan, El Dorado Irrigation district and Golden State – Cordova. Rio Linda can receive water through the CTP or RiverArc.
 - The agencies discussed how the Alder Creek Reservoir could allow for increased storage and flood protection and operational flexibility.
