    - Identified Mitigation Actions
      - Projects within a given category (e.g., groundwater well injection, recycled water) may have different contribution to objectives designation (high, moderate, low).
         It will depend on the project/agency.
      - Contribution to objectives designations on the summary table should be modified to better describe overall drought resiliency and conjunctive use goals/focus for this region.
    - Retained Mitigation Actions
      - It will be easier to comment on the individual mitigation action designations versus the category designations, per reasoning described above.
      - Participants were reminded to review the vulnerability-mitigation action tables distributed last week to ensure that all of their potential mitigation actions have been included and accurately described. Due date for drought-related actions is Friday, April 14, 2017.
