Legislative and Regulatory Update

AB 1668 and SB 606: Long Term Efficiency

- Water Agency Level Water Budget
 - Residential indoor/outdoor water use
 - CII Dedicated Irrigation Meter use
 - Water Loss (SB 555)
 - Finalize targets by 2022
- Water Supply Planning
 - 5 year dry year planning
 - Increased reporting
 - Consistent Water Contingency Plan format



Legislative and Regulatory Update

AB 3206: Meter Accuracy Testing

- Meter Accuracy Standards by 2020
- Installed, purchased or under contract meters ok until end of useful service
- Affects meters that are sold in CA as well
- May consider most recent AWWA standards
- Require the sampling and testing by each urban water supplier of its customer service meters that, when followed, will produce a statistically sound estimate of the accuracy of the urban water supplier's meter fleet



Legislative and Regulatory Update

SB 555: Water Loss Validation

- Validated water audits every October 1st
 - Validator cannot be the same person that performs the audit
- Water loss standards in the future
- What is your agency doing to validate this year?
 - In house?
 - Consultant?
- Interested in
 - RWA consultant contract?
 - RWA staff?



Legislative and Regulatory Update

SB 998: Water Shut Off

- Agencies with more than 200 service connections
- Require written policy on discontinuation of water service to certain residences for nonpayment
- Enforcement-civil penalty-not to exceed \$1,000/daycollected by the SWB-go to Safe Drinking Water Account
- Can't shut off water until delinquent for at least 60 days
- Prohibit discontinued service under specified circumstances, low income, etc.
- Reporting on shut offs from no payment
- By 2020



Legislative and Regulatory Update

Permanent Water Waste Prohibitions

- Sidewalk, recirculating fountains, shut off nozzle, turf medians
- Presented draft in February 2018
- On hold until further notice
- Expected to announce 3rd public comment period in the next few months




