2. Public Comment

3. Approval of previous meeting minutes

Approval of the minutes from the June 15, 2022 RWA Federal Affairs Standing Committee Meeting.

M/S/C Mr. Jacobs moved, with a second by Mr. Sanders, to approve the minutes of the June 15, 2022 RWA Federal Affairs Standing Committee Meeting. 4. Disclosures and Regional Coordination

Chair Sanger reported that the American River Basin Study results were released today. RWA was a partner in technical work. It was suggested that RWA leverage this opportunity at the federal level with the water bank. There is also an opportunity to connect climate change with the solutions we have for water supply.

Mr. Peifer said that the ACWA DC conference was successful with many office visit appointments that educate members of Congress and their staff on our needs. We are gaining support for our water needs from our Senators through communication.

5. Federal Legislation Review

- a) Chair Sanger mentioned the proposed rule making process on PFAS and cyber security mandates that will be coming to local water agencies. There was discussion on the Inflation Reduction Act, the funding increasing for households with an unreliable water source or underserved communities and the Water Smart Program. Most of the funding will go to current Water Supply Programs.
- b) The Governor's Water Supply Strategy includes streamlining the permitting process for wet years.
- c) Ms. More said that final FY23 budget bills will not be acted on until after the election or later. It was noted that control of congress could change.
- d) There was discussion on the funding amount for Reclamation under the Bipartisan Infrastructure Law.
- e) There are pending waivers at some agencies for the Buy American

Implementation. There are challenges on the water side with the Buy American Mandate and the time period for exemptions and compliance. Mr. Sapirstein gave an update on cyber security mandates and on the EPA rule making on PFAS.

f) Anyone who received ear marks in 2022 under the Sacramento area are working with the Corp to finalize those agreements. Challenges remain on how to receive Section 219 funding.

6. Water Bank & MOA Update

Ms. Banonis said that Reclamation is waiting for some policy guidance to determine feasibility.
