7. EXECUTIVE DIRECTOR'S REPORT

Executive Director Peifer reported that the Artesian Agreement is now finalized and that many of the organizations will receive part of the 55 million received from DWR and reminded the Committee to deliver their CEQA paperwork to Michelle Banonis as soon as possible. He told the committee that a USBR Be Water Smart Grant Solicitation will be released soon.

Executive Director Peifer reminded the Committee that RWA will be hosting a Member Reception at the Fall ACWA conference on Wednesday, November 29 at 6:30 pm at the Vue Grille & Bar located at the Indian Wells Golf Resort and the SGA's 25th Anniversary Event is on September 21st at the Sutter Club.

8. DIRECTORS' COMMENTS

Director Saunders reported on September 8, 2023, there is a webinar for Water Use Efficiency.

Director Ewart City of Sacramento reported the City of Sacramento and the City of West Sacramento have started talking emergency pipelines connections and plan to start work on them in the next couple of years.

Director Bigley reported that he will be starting to drill two wells and spoke of possibly taking video and footage of the drilling. The DWR Funded wells will start August 23, and the second will start on September 20th for approximately 2 weeks on this project. The Roseville State of Water is on August 29, at 6:00 pm. hosted by Director Bigley, George Hansen (Weather Utility manager), and Bobby Alverez (Water Conservation Manager).

Director Greenwood reported Carmichael Water District is continuing to work on Environmental Planning. Progress is still being made on the consolidation and reorganization of Carmichael Water District and Sacramento Suburban Water District.

The community has concerns over governance and the process. This District recently approved the TURF Program and the buyback program.

Director Foster gave kudos to those that attended the GM Directors meeting, put on by RWA. He said that it was a wonderful opportunity for Water professionals to be in the same room and gave his consensus to be with everyone and network. He thanked Jim Peifer for hosting the meeting.

Chair Firenzi reported that we are a region of 2 million people with more than 21 water agencies, and he appreciates that the RWA can meet and cohesively work together to discuss the water issues. Reported the River Arc project is being recommended by Wildlife Conservation with a 5-million-dollar Grant. He also reminded the Board there will be a Federal tour with the Nature Conservatory on October 4th.
