|            | <p>Charlotte Ely provided the State Water Resources Control Board (SWRCB) perspective on the proposed conservation regulation. She had received limited feedback from suppliers to date and recommended agencies participate in the upcoming October 4th public meeting. As currently proposed, suppliers would have to report on the regulation to both the California Department of Water Resources (DWR) and the SWRCB. This increases the cost of reporting and potentially creates data quality issues between the agencies. The first reports are due on January 1, 2024 to DWR using their recently development reporting template. Suppliers stated it would be ideal for there to be a portal for agencies to report once with the data accessible by both DWR and SWRCB.</p> <p>Amy reviewed the basics of the regulation text in a presentation and asked the group for feedback on supplier concerns. The outdoor residential standard and performance measures consistency were mentioned.</p> |
| Next Steps | <p>There is a RWA General Manager/Board Workshop to discuss the proposed regulation at a high level on September 19, 2023.
