4.0 Annual WEP Budget Discussion	
	The program approved a 3% increase in dues for fiscal year 2024-2025, which will go into effect on July 1, 2024. RWA policy indicates RWA can't use WEP reserves for RWA expenses; WEP reserves are only for designated WEP related projects. For future years, the program expects to propose an annual 3-5% increase to keep up with inflation.
	Agencies requested that the annual budget be discussed earlier in the year to provide more time for internal supplier discussion. Amy will revisit the fiscal year 2025-2026 budget projections and potential conservation regulation implementation fiscal impacts (which should be adopted by this time) at the November 2024 RWEPAC meeting.
