| USBR Grant Application<br>Update | RWA submitted our application on November 8 <sup>th</sup> requested \$1.87M in federal funding. The proposed project includes turf replacement rebates, irrigation controller rebates and direct installation for DAC communities. Notice of awards is expected in May 2025 with funding to be available in October 2025. |
| 2025 Outreach Priorities         | This discussion was postponed until the January RWEPAC meeting.
